- \*\*\* The Affordable Care Act requires you to maintain basic health care coverage—called minimum essential coverage. If you don't have coverage, you may have to pay a fee for each month you aren't covered.
- \*\*\* As you prepare your taxes this year, please be sure to visit the Proof of Minimum Essential Coverage page on TRICARE.mil.

- >>>> Homeless, Terminally ill, Medal of Honor Recipients, Former POWs, Financial Hardships, OIF/OEF, VSI/SI, Pre-discharge, &Fully Developed Claims.
- >>>> Claims pending over 125 days and Roll-Overs
- · Making Sense of VA Disability Claims:
- \*\*\* The Disabled American Veterans created five new "quick reference" videos that outline everything from who should file a claim to what to expect after receiving a decision on a claim.

- \*\*\* The videos are concise, to the point and designed to be free of confusing government jargon.

- Appeals Process at the Local VA Regional Benefits Office Level:
- \*\*\* If you disagree with VA's decision for any reason the effective date of your award, the rating percentage you were given or the reason you were denied you should file a Notice of Disagreement (NOD) within one year from VA decision date.
- \*\*\* You have several rights:
- >>>> Submit new evidence.
- >>>> Request a de novo review by a senior-level, highly experienced claim processor who can grant your appeal, deny your appeal and issue an SOC, or order additional information / exam.
- >>>> Ask to testify and present evidence at a telephone or in-person hearing.

- VA Reevaluates Blue Water Navy Definition:
- \*\*\* The Department of Veterans Affairs reevaluated and clarified its definition of "inland waterways" on 4 February 2016 per the Veterans Court of Appeals for Veterans Claims decision, Gray v. McDonald.
- \*\*\* For purposes of adjudicating disability claims regarding Agent Orange exposure in Vietnam, VA will now determine if a body of water is considered an inland waterway by drawing straight lines across the opening in the landmass leading to the open ocean or other offshore water feature, such as a bay or inlet.
- Team Red, White and Blue Involvement Benefits Veterans:
- \*\*\* The officials from Syracuse University's Institute for Veterans and Military Families released its new study on Team RWB that involved more than 270,000 individuals took part in group events last year.
- \*\*\* Of veterans surveyed, 81% said their involvement made them feel more satisfied with their lives, 64% said it helped them maintain a healthier weight,

- 53% said it helped them better connect to their civilian peers & 70% said it helped them build a better network of professional contacts.

- VA Improves Timeliness of Provider Payments:
- \*\*\* To enhance Veterans' access to care and eliminate payment delays in Choice provider, the Department of Veterans Affairs is reducing the administrative burdens placed on VA community providers
- \*\*\* Previously, payments to Choice providers were not allowed until a copy of the Veteran's medical record was submitted.
- \*\*\* Now, community providers, under the Choice program, will no longer be required to submit medical records prior to payment being made.

- Active Duty Suicides Up, Reserve Component Suicides Down in 2014:
- \*\*\* As seen in previous years, most service members who died by suicide in 2014 were men under age 30, mostly enlisted, white and married.
- \*\*\* The 2014 deaths shared the below commonalities:
- >>>> 50% had a mental health diagnosis, with the most common being mood or adjustment disorders or substance abuse.
- >>>> In the enlisted ranks, infantry personnel, gun crews or seamanship specialties had the highest rates of suicide, 21%, followed by electrical or mechanical equipment repairers, 18.9%.
- >>>> The occupational specialties with the highest suicide rates for officers were tactical operations, at 4.3%.
